1. PURPOSE OF THIS FORM

A full commercial licence is granted on all delivered assets. The underlying AI model trained on client assets remains a tool of The AI Marketing Studio for the duration of the active client relationship. Upon project completion or subscription cancellation, the model is archived and not used

for any other client or purpose.

- Confirm deletion in writing
